## 15 year limited Warranty

Lucid Inc. warrants to the original purchaser only that this Lucid Acoustics Loudspeaker Product will be free from defects in material and workmanship for a period of five (5) years on speakers and two (2) years on electronics from the date of original retail purchase from a Lucid Acoustics Authorized Dealer. However this warranty will automatically terminate prior to the expiration of the five (5) years on speakers and two (2) years on electronics if the original purchaser sells or otherwise transfers the product to any other party. The original retail purchaser shall hereafter be referred to as "you." To allow Lucid Acoustics to offer the best possible warranty service, register your product online at [www.lucidacoustics.com](http://www.lucidacoustics.com). An additional ten (10) years of warranty coverage is available on speakers that are installed and adjusted by an authorized Lucid Acoustics dealer who is certified to do so. Product registration is mandatory to qualify for the additional ten (10) years of warranty, along with a faxed or mailed copy of the original receipt with installation itemized on the receipt.

Defective Products must be shipped, together with proof of purchase, prepaid insured to the Lucid Acoustics Dealer from whom you purchased the product, or the Factory at 815 N. Red Rock Rd. Suite 6, St. George, Utah 84770. Products must be shipped in the original shipping container or its equivalent: in any case the risk of loss or damage in transit is to be borne by you. If upon examination at the factory or Lucid Acoustics authorized dealer it is determined that the unit was defective in materials or workmanship at any time during this warranty period. Lucid Inc. or the Lucid Authorized dealer will, at its option, repair or replace this product at no additional charge, except as set forth below. All replaced parts and products become the property of Lucid Inc. Products replaced or repaired under warranty will be returned to you, within a reasonable time, freight prepaid.

This warranty does not include service or parts to repair damage caused by accident, disaster, misuse, abuse, negligence, inadequate packing or shipping procedures, commercial use, voltage inputs in excess of the rated maximum of the unit, cosmetic appearance of cabinetry, or service, repair, or modification of the product which has not been authorized or approved by Lucid Acoustics. This warranty shall terminate if the serial number on the product has been removed, tampered with or defaced.

All implied warranties on this product are limited to the duration of this expressed Warranty. Some states do not allow limitation on how long an implied Warranty lasts, so the above limitations may not apply to you. This Warranty gives you specific legal rights, and you may also have other rights which vary from state to state.

This warranty applies only to products purchased in the United States of America and its possessions. The Warranty terms and conditions applicable to Products purchased in other countries are available from the Lucid Acoustics Authorized Distributors in such countries.
